

DEED TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, That J. J. W. Norwood as Trustee

in the State aforesaid in consideration of the sum of Five hundred Dollars

and other valuable consideration to me in hand paid and before the sealing of these presents by E. W. Holdemith

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. W. Holdemith of the County of Greenville, State of South Carolina,

all that piece or parcel of land in City of Greenville on the Western side of Afton Avenue in Alta Vista, being known as Lots Nos. 51 and 52, according to plat recorded in R.M.C. Office for Greenville County in Plat Book "B" at Page 20 and more particularly described according to said plat, as follows:

Beginning at a point on the western side of Afton Avenue, joint eastern corner of Lots Nos. 50 and 51; thence with line of Lot No. 50 N. 85.40 E. 160 feet to point in line of Lot No. 39; thence along the rear line of Lot Nos. 51 and 52 S. 14-15 N. 120 feet to point in line of Lot No. 37; thence along the line of Lot No. 53 S. 85.40 E. 160 feet to point on Afton Avenue; thence with Afton Avenue N 14-15 E. 120 feet to point of beginning.
