

TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, That I, J. D. Halliday

in the State aforesaid in consideration of the sum of One (\$100) Dollar and the assumption of mortgage by hereinafter described in Mortgage Book 163 page 167 to August 26 1885 on me paid by J. D. Huff

in the State aforesaid the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. D. Huff here and his heirs, assigns and interest the same being an undivided one-half interest in Tract 75 all that piece, parcel or lot of land in Tract 75 Township, Greenville County, State of South Carolina,

near the Grove Road, and having according to the survey of R. E. Patton the following metes and bounds, to wit:

Beginning at a chestnut stake in line of S. A. Hollingsworth land and running thence S 85 1/2 E. 574.8 feet to an iron pipe, thence S 25 45 E. 379 feet to a stone, thence N 87 W. 593.6 feet to an iron pin in a branch, thence up the meanders of the branch approximately as follows: N 17 50 E. 112.2 feet; thence N. 13 E. 200 feet, N. 19 25 E. 118 feet, N. 12 15 E. 175 feet, N. 30 55 E. 150 feet, N. 4 35 W. 74.6 feet, N. 41 20 E. 127.2 feet, N. 56 15 E. 100 feet to an iron pin in said branch, thence N 87 25 W. 607.9 to a stone, thence N. 44 50 W. 487 feet to an iron pin, thence S. 77 W. 540 to a stone, thence N. 77 10 W. 477 feet to a stone, thence S. 24 20 E. 139.3 feet to a chestnut stake, the point of beginning.
