

LEASE

THE STATE OF SOUTH CAROLINA,
County of Greenville.

I, E. M. Gilstrap, in consideration of the sum hereinafter mentioned, have granted, bargained and released as I by these presents do grant, bargain and lease unto P. C. Williamson, Lessee, some new base from construction 14 by 16 feet on Cedar Lane Road

for the following use, to-wit: _____

for the term of one year from date with option of four additional years at expiration of one year and the said lessee

in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of Three (\$4.00)

per week payable on Saturday of each week

The lessee hereby agrees to take the building just as it stands unless otherwise agreed upon in writing, and the lessee only requires of the lessor the use of the premises for the business mentioned but no other. The lessee to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from leaks should any occur. This of the premises for any business other than herein set forth shall cancel this lease if the lessee so desires and give notice of same in writing.

If the business is discontinued by the promisor vacated before the expiration of the lease then the whole of the aforesaid time becoming immediately due and payable.

Outside signs to be erected that may connect with the parapet or any other outside part of the building must be consented to by the lessee before being erected.

It is specifically understood that the lessee is to cover all repairs to said building, except repairing of floors and doors which is to be done by lessor

The above and to all the other promises with the said lessee, P. C. Williamson executor and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party one months written notice previous

to the date of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or the expiration of the term, shall terminate this lease, if the lessor so desires. The lessee agrees to make good all breakage of glass and all other injuries done to the premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the written consent of the lessor per sub-lease without the lessors written consent.

The lessee hereby acknowledges having a duplicate of this lease.
