(The receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
Mrs. Mary McM. Bailey, her heirs and assigns forever:

All those certain pieces, parcels or lots of land situated, lying and being in Greenville Township, Greenville County, State of South Carolina, West of the City of Greenville, known as Lots Nos. 20 and 21 of Block "D", on plat of Summitt View, recorded in Office of R. M. C. for said County in Plat Book "A", at page 75, said lots having the following courses and distances according to same plat:

Beginning at a stake on the South-east side of Redstone Street, corner of Lot No. 23, and running thence with line of said lot S. 50 E. 150 feet to a ten foot alley; thence with said alley N. 40 E. 100 feet to a stake, corner of Lot No. 19; thence with line of said lot N. 50 W. 150 feet to a stake on Redstone Street; thence with Redstone St. S. 40 W. 100 feet to the beginning corner, and being the same lots of land conveyed to me by Julia D. Charles by deed dated Oct. 11th, 1922, and recorded in the R. M. C. office for said County in Deed Book Vol. 72, at page 362.

Also all that other certain piece, parcel or lot of land situated, lying and being in said County and State adjoining the above described lots, and being known as Lot No. 22 of Block "D", of said plat, and having the following notes and bounds, to-wit:

Beginning at a stake on the South-east side of Redstone Street 65 feet from Church Street, corner of Lot No. 23 and running thence with line of said lot S. 50 E. 150 feet to a stake on a ten foot alley; thence with said alley N. 40 E. 50 feet to a stake, corner of Lot No. 21; thence with line of said lot N. 50 W. 150 feet to a stake on Redstone Street; thence with Redstone Street N. 40 W. 50 feet to the beginning and being the same lot of land conveyed to me by Julia D. Charles by deed dated Dec. 7th, 1923, and recorded in the R. M. C. office for said County in Deed Book Vol. 97, at page 55.

As the consideration hereinabove expressed the grantee assumes the payment of a Hundred and Fifty Dollar (\$150.00) mortgage with the interest thereon, recorded in the R. M. C. Office for Greenville County in Vol. 199, at page 123.
