Being the same lot of land conveyed to me by Mrs. Elizabeth C. Holland Sr., by deed dated May 4, 1928, and recorded in Vol. 127, at page 102".

TOGETHER with all and singular the Dower, Fiefdom, Bannlements and Appurtenances to the said Property belonging or in anywise incident or appertaining and all the estate, right, title, claim and interest whatsoever, of the parties to the writing, except as "left" of them in trust to the same and of all other persons rightfully claiming from, under, or by these or any of them.

TO HAVE AND TO HOLD, I, and singular, the premises before mentioned, unto the said First National Bank of Greenville, S. C., as Guardian as aforesaid, its successors and assigns forever, in trust nevertheless to hold the legal title to the property and to lease or rent the property on such terms as it may think best, with full power to sell said property either at private or public sale and to re-invest the proceeds of said sale as it may determine to be to the best interest of said minors, provided, however, that the purchaser shall not be required to see to the application of the proceeds of the sale.
