## WARRANTY DEED

This Indenture made and entered into this 8th day of September, 1932, between The Buckeye Cotton Oil Corpany, a corporation organized under the laws of the State of Thio, as party of the first part, and H. B. Peden, of Greenville, South Carolina, as party of the second part, WITNESSETH:
