State of South Carolina, County of Greenville,

This agreement made and entered into between Luta B. Sullivan, Individually, W. W. Sullivan, Ludividually, and Lila E. Sullivan, W. W. Sullivan and Jake W. Sullivan as Executors of the last will and testament of N. B. Sullivan, deceased, and as Trustee under the same parties of the First Part, and W. D. Parrish, T. C. Gower, E. M. Wharton, W. W. Burgiss, and W. H. Balentine, Parties of the second part witnesseth:

Whereas the parties of the first have recently acquired from Louis L. Barr and Ella D. Barr, by deed recorded in Vol. 32, page 350, two certain lots of land, one fronting on Main Street and the other fronting on North Street in the City of Greenville, South Carolina, which said lots are separated by an alley way which extends in a southerly direction from North Street in the first block West of Main Street and which was opened and is maintained for the use and benefit of the owners and occupants of the several lots owned by the parties of the second part and parties of the first part,

Whereas the parties of the first part are now constructing an underground passage—
way under and across said alley for the purpose of connecting their lots above mentioned
and in the course of such construction have altered the location of certain pipes running
from North Street to the lots belonging to certain of the parties of the second part and
the parties of the first part intend to construct an overhead passageway over and across
said allegray connecting the second stories of their buildings on said two lots belonging
to the parties of the first part, such passageway to be so constructed as to leave said
allegray clear and unobstructed for its full width to a height of 14 feet above ground.

Now therefore the parties of the second part do hereby agree and consent to such change in the location of such pipes and to the construction of the everhead passageway as afterested and do hereby release the parties of the first part from any claim or claims for the damage on account of same,

And the parties of the first part do hereby grant and confirm unto the parties of the second part their beirs and assigns the right to construct and maintain underground lines of water, sewage, drainage and gas pipe and conduits for wires along and under the said alley way where the same abuts upon the property of the parties of the first part and in and through the underground passageway connecting the said two lots of the parties of the first part, with the right to make necessary excevations in said alleyway and to enter said passageway for the purpose of laying, constructing, repairing and moving such pipe lines and conduits.
