Parcel Two: All that certain tract of land situate, lying and being in Grove Township, Greenville County, State aforesaid, on west prong of Roedy Fork Creek, bounded by lands of J. M. Blackley, John Davenport and others, described as follows; Beginning at a stone 3ron near a blackjack and running thence N. 77½ W. 9.50 to a stone 3xnm; thence N. 70½ W. 11.00 to twin water-oaks 3xnm; thence S. 51½ W. 2.25 to a large water-oak 3xnm; thence N. 57 W. 2.90 to a black-gum 3xnm; thence N. 83½ W. 18.57 to twin post-oaks 3xnm; thence S. 47-3/8 W. 9.80 to twin sweet gums 3xnm; thence S. 89½ W. 3.49 to a stone 3xon, near double gum; thence S. 5 E. 24.50 to a stone 3xon (old sassafras); thence S. 72 W. 4.90 to a stone 3xon; thence S. 76½ E. 50.28 to a stone 3xon; thence N. 16 E. 33.84 to the beginning corner, containing 170 acres, more or less; being the same premises conveyed by The Realty Trust Company to J.
