## WITNESSETH:

That Roy E. Knight, as lessor, has granted, and by these presents does grant, bargain and lease unto the said R. A. Knight and E. A. Knight, as leasees the following described real estate:

All that certain piace, parcel or lot of land beginning at a point on the Augusta Road near the north and of the store building, and extending along the East side of said augusta Road to a point beyond the seed house a distance of 300 ft. more or less; thence in a line perpendicular to said Augusta Rort a distance of 200 ft.; thence in a line parallel to the Augusta-Road a distance of 300 ft. more or less; thence in a straight line to the beginning point on Augusta Road a distance of approximately 200 feet; near the corner of the store building.
