All that certain piece, parcel or lot of land situate and being in the County and State aforesaid, on the South side of Byrd Boulevard, and having the following metes and bounds, to-wit:

Beginning at a stake at corner of lot No. 152 and running thence S. 60-28 E. 70' to a stake; thence S. 29-32 W. 300' to a stake; thence N. 60-28 W. 70' to a stake; thence N. 29-32 E. 300' to the point of beginning, and being lot No. 151 of Traxler Park,

Subject, however, to the following restrictions:

- 1. No part of said lot shall be used for any purpose other than a single or multiple residence and outbuildings properly appertenant thereto.
2. No part of said lot shall be occupied by any person or the negroid races except in the capacity of a servant.
3. Out buildings properly appertenant to a residence shall be confined to the rear half of the lot upon which they are built unless they shall be integral to the residence to which they appertain.
4. No part of any residence may be built or extend nearer to the front property line of said lot then 35 ft.
5. No residence may be built upon any lot fronting upon Byrd Boulevard or Park Drive which shall have when completed, a reasonable value of less than \$4,000.00, and no residence may be built upon any lots fronting upon Rock Creek Drive, Woodvale Ave., or Mountivista Ave., which shall when completed have a reasonable value of less than \$3,500.00
6. No spirituous or malt liquor shall ever be manufactured or sold upon said lot.
7. These restrictions are imposed for the benefit of the grantor any may be modified by it when strict modification is desired by him to the best interest of all concerned.
