M. Furman, Jr., Engineer March 26, 1923, recorded in the office of R. M. C. for Greenville County in Plat Book "F" at page 148, the same being Lot No. 27 on said plat and the new boundary of Lot No. 28 as shown on plat and plat of Home Builders Company, said Lot No. 28 fronting 52.6 feet on Laurens Road instead of by the old plat of 42.6 feet.
