Sloan Westmoreland all that piece, parcel or lot of land in Batee Township, Greenville County, State of South Carolina, and on the Town of Travelers Rest on the west side of the Geer Highway, known and designated as lot #2 of the W. H. League property according to a plat or survey made by W. H. Weston August 18, 1902 and having the following metes and bounds to wit:
