Battle Township, and at the intersection of Buncombe
Road Highway 26, and the Sigerville Road about one mile
north of Seabees Rest, and having the following metes
and bounds, to wit:

Beginning in the fork of the said roads, and running
thence S. 85 $\frac{1}{2}$ E. with the Sigerville Road, one hundred and
forty (45') five feet to a point in the center of said road;
thence N. 14 $\frac{1}{2}$ E. one hundred ten (110') feet to an iron pin;
