(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
H. C. Wood, his heirs and assigns forever:

First: All that certain piece, parcel or lot of land situated, lying and being in Greenville County, State of South Carolina, about one miles West of the City of Greenville and near Monaghan Mill, in Sub-Division known as "New Hope" said lot known as lot #2 and being on Hoyatt Street--designated on a plat of said "New Hope" as is shown by record of said Plat in R. M. C. Office in and for Greenville County Plat Book "A", at page 307, and being the same lot of land conveyed to me by J. H. Welch by deed dated Nov. 11th, 1923 and recorded in the R. M. C. Office for Greenville County in Book Vol. 92, page 283.

X Second: All that piece, parcel or lot of land situated, lying and being in the County and State aforesaid, near the American Spinning Company's property, and lying on Street leading from road connecting the American Spinning Company's property with Paris Mountain Road.

Beginning at an iron pin on the South side of said Street at the corner of land now or formally belonging to Irvin; thence S. 23 1/2 W. approximately 190 feet to an iron pin; thence N. 56 1/2 W. 55 feet to an iron pin; thence N. 23 1/2 E. approximately 190 feet to street; thence with said Street S. 56 1/2 E. 55 feet to the beginning corner and being the same lot of land conveyed to me by E.
