in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said B. F. Reese, all of our right, title and interest in,

all that piece, parcel or lot of land in Highland Township, Greenville County, State of South Carolina, having the following metes and bounds, to-wit:

Beginning at an iron pin in the center of Few's Bridge road and runs thence N. 35-00 W. 1703 feet to an iron pin and lightwood knot; thence S. 52-08 E. 314.5 feet to stone; thence N. 32-58 W. 287.5 feet to stake, W. O. gone O. M.; thence S. 59 W. 385.5 feet to stake; thence S. 9 E. 129 feet to poplar 3x; thence S. 9-05 W. 224 feet to W. O. 3x; thence S. 8-15 W. 207.5 feet to poplar 3x; thence S. 10-30 W. 182 feet to Walnut (dead); thence S. 13-30 W. 143 feet to stake; thence S. 8 E. 207 feet to three poplars on branch; thence S. 88-08 E. 513 feet to stake on bank of branch; thence S. 26-30 E. 841 feet to point in center of said Few's Bridge road; thence N. 51 E. 100 to slight bend in said road; thence N. 46 E. 500 feet to another bend in road; thence N. 57 E. 100 feet to bend in road; thence N. 68 E. 300 feet to another bend in road; thence N. 74-45 E. 100 feet to an iron pin center of said road; the beginning corner and containing Forty-four and 56/100 (44.56) acres, more or less,

O. 3x; thence N. 9-05 E. 224 feet to poplar 3x; thence N. 9 W. 129 feet to stake; thence S. 59 W. 742 feet to stake in W. O. stump W. O.
