

The State of South Carolina, } BY THE SECRETARY OF THE STATE.

WHEREAS, *E. D. Bridges and Henry A. Besoks both of Greenville, S.C.*

did on the *28th* day of *March*, 193*6*, file with the Secretary of State a written Declaration signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed Corporation is *S. P. Corporation*

THIRD: That the principal place of business is *Greenville, S.C.*

FOURTH: That the general nature of the business which it is proposed to do is *among other things, to conduct general mercantile business, but principally automobile, automobile supplies, as well as buying, selling and exchanging personal property of every description; to buy, own, improve, and sell real estate for profit; to act as agent or broker for others in negotiating sales for both personal property and real estate; to buy, own and sell stock in other corporations, and securities of every description whenever deemed advisable by the officers in charge; to loan money and take security therefor, and to do any and every form of trading, buying and selling for a profit whenever the officers in charge may deem it expedient*

FIFTH: That the amount of the capital stock is *Six Thousand (\$6,000.00)* Dollars, payable *as called for by the directors*

SIXTH: That the number of shares into which the capital stock is divided is *sixty (60)* of the par value of *One Hundred (\$100.00)* Dollars

SEVENTH: That, after due notice, a meeting of the subscribers was held on the *23rd* day of *March*, 193*6*, at which a majority of all stock in value being present in person or by proxy the following were elected directors: *H. R. Stephenson, Martin Bridges and E. D. Bridges*

EIGHTH: That subsequently there was elected as President *H. R. Stephenson* as Vice-President, *Martin Bridges*; as Secretary, *E. D. Bridges* as Treasurer, *Martin Bridges*

NINTH: That all requirements of Article 2, Chapter 153 Code of Laws of South Carolina, 1932, and all amendments thereto, have been duly and fully complied with, 50 per cent, of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent, of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in *The Greenville News* a newspaper published in the County of *Greenville*.

NOW, THEREFORE, I, *W. P. Blackwell*, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
