(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Mrs. Regina B. Reynolds All that certain piece, parcel or lot
of land situate, lying and being in Ward Six of the City of
Greenville, Greenville County and State of South Carolina, and
having the following metes and bounds, courses and distances,
according to a survey of the same made in April 1934 by Dalton
& Nease, Engineers:

Beginning at an iron pin at the south west corner of the intersection of Cleveland Street and Belmont Avenue and running thence
along Belmont Avenue S. 4° 2' W. 84 feet to an iron pin, corner of
Alice L. Neusner property; thence running with her line D.P.
84-58 N. 136.3 feet to an iron pin at the south east corner of the Hugh
V. Walker property; thence running with his line N. 7.45 E. 47 feet to an
iron pin on Cleveland Street; thence along Cleveland Street S. 79-
25 E. 1.31 feet to the point of beginning.

This being the eastern portion of my home place where I now reside,
which was conveyed to me by deed of Margaret A. Walker dated
December 24th, 1930, and deed recorded in the office of the C.R.C. for
Greenville County in Vol. 158 at page 204.
