All that certain piece, parcel or lot of land situate in the State and County aforesaid, Butler Township, adjoining lands of K. A. Bull, W. W. Smith, Ed. Butler and others, being a part of the tract of land formerly conveyed by Henry Stroud to M. A. Hendrix, Beginning at a stake on Greenville-Pelham Road, thence N. 61-30 W. 460 feet to stone; thence N. 42 W. 509 feet to stone; thence N. 24-40 E. 330 feet to stone; thence N. 25-20 W. 364.5 ft. to stone; thence N. 33- E. 1663 ft. to stake in mouth of ditch on Big Rocky Creek; thence S. 52-20 E. 185.5 ft. to point; thence S. 95 E. 100 ft. to point; thence N. 57 E. 100 ft. to ditch bank; thence N. 41.45 E. 60.3 ft. to point on ditch bank; thence S. 15- E. 402 ft. to stake; thence S. 42-30 W. 290.5 ft to stone; thence S. 39.15 E. 502.2 ft. to stake; thence S. 33.15 E. 615 ft. to stake in Greenville-Pelham Road; thence along said Road S. 37.30 W. 914 ft. to stake in bend of road; thence continuing along said road S. 56.15 W. 657 ft. to the beginning corner, containing 66 acres, and being designated as Tract No. 1 on plat prepared by E. S. Brockman Surveyor, dated Oct. 25, 1933.

Also all that certain piece, parcel or lot of land in said Township, County and State, containing 11 acres, beginning at stone, Sue Butler corner, thence N. 0.15 E. 662 ft to large stone; thence N. 54.15 W. 340 ft to Birch at or in Big Rocky Creek; thence along meanderings of said Creek N. 45.45 E. 160.3 ft; thence N. 37 E. 100 ft; thence N. 41.30 E. 200 ft.; thence N. 86 E. 191.5 ft; thence S. 49.15 E. 197 ft to stone; thence S. 1.15 E. 1100 ft to oak in place of stone gone; thence N. 68.15 W. 387 ft to the beginning corner, bounded North by lands of est. of Henry Stroud; East by lands of est. of David Bolton; south by lands of Sue Butler, and West by lands of Sue Butler, together with 8 foot right of way from the south-east corner to the Greenville-Pelham Road, and being designated as tract No. 2 on plat of H.
