on the main road leading from Greenville City to the Saluda Dam, and known as the White Horse road, about three miles from the City, and having the following metes and bounds, to-wit;

Beginning at a stake on the aforesaid road, joint corner of the lands of E. M. Gilstrap and Mrs. Freeman, and running thence with Mrs. Freeman's line, S. 50 W. 200 feet to a stake in line of E. M. Gilstrap and Mrs. Freeman; thence S. 50 E. 200 feet to a stake in the field of E. M. Gilstrap; thence N. 50 E. 200 feet to a stake on Saluda Dam Road, corner other lands of E. M.
