All that certain tract of land situate in Greenville county, South Carolina, Saluda Township, on the southeast side of the Greenville-Hendersonville Highway (formerly known as the Buncombe road), about 24 miles from Greenville court-house, and having the following metes and bounds, according to a survey made by W. A. Hester, surveyor, dated Aug. 10, 1925 to-wit:
