all that piece, parcel or lot of land in Glassy Mtn. Township, Greenville County, State of South Carolina.

All that certain lot known and designated as Lot 54, of Plat No. 1 of the property of Tryon Development Company, known as Lake Lanier, made by George Kershaw, C. E. and duly recorded in the office of R.M.C. for Greenville County in Plat Book No. _____ page _____ being Lot No. 54 of the Holmes Hill Section of the Lake Lanier Subdivision and Beginning at a point in the center line of Lake Shore Drive at a distance of 1,773.5 feet more or less at its intersection with the Tryon Spartanburg Highway, said point being located exactly 48.5 feet Southward from the point of curvature of a circular curve with a radius of 355.0 ft. said beginning of curve being duly reference by two concrete monuments as shown on the aforesaid plat, and running thence along the center line of Lake Shore Drive a distance of 59.5 feet; thence along a line radical to said curve to the center line of the first Street East of Lake Shore Drive (a distance of 216.0 feet more or less); thence northward along the center line of said street a distance of about 32 feet to a point of intersection of said center line of said street with a line drawn radical to the aforesaid curve from the point of beginning of this description and thence along the said radical line a distance of 198.0 feet more or less to the beginning, saving and excepting a strip of land adjacent to the center line of Lake Shore Drive bounded by a line to the east, of, parallel to and 15 feet distant from the said center line, and a strip of land adjacent to the center line of first street to the east of Lake Shore Drive, bounded by a line to the west of, parallel to, and 15 feet distant from the center line of said street, which two strips of land are reserved for use by the public as streets, and be it understood that all distances described as curved lines are to be measured in chords of 25 feet and fractional parts and that the said lot has a width at the building line, as indicated on the part of 50 feet or more.

This is the identical property which was conveyed by Tryon Development Company to Eva M. White by deed dated May 8th, 1925, recorded in Volume 119 at page 159 R.M.C. for Greenville County, S. C., and this conveyance is subject to all valid restrictions, limitations and conditions contained in said deed.
