NOW, THEREFORE, Know All Men by These Presents, That I, E. INMAN, Master in and for the County of Greenville, aforesaid, in consideration of the sum of Sixty Eight Hundred (\$6800.00) Dollars to me paid by the said Mrs. S. S. Dorron,

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these Presents DO GRANT, bargain, sell and release unto the said Mrs. S. S. Dorron,

"All that lot of land in the County of Greenville, State of South Carolina, beginning on the north-west corner of Block "C" of the Buist property, according to a plat thereof recorded in the Office of the R. M. C. for said County and State in Plat Book "C" at Page 10, (which corner is marked by a stake on the south side of Mountain View Avenue, on the east side of a 15 foot alley, 215 feet Eastward from the Southeast corner of Mountain View Avenue and Townes Street), and running thence along Mountain View Avenue S. 80.15 E. 240 feet to a stake; thence S. 9.45 W. 363 feet to a stake on the north side of Buist Avenue; thence along Buist Avenue N. 80.15 W. 240 feet to a stake on the corner of said 15 foot alley; thence along said alley N. 9.45 E. 361 feet to the beginning corner.
