Remand and judgment in the above cause were entered and described, and the cause being at issue, came on to be heard on the **24th**
day of **May** 19**35** proceedings were had therein as resulted in a Decree

of the Court of Common Pleas of the County of Greenville, to wit: that the premises mentioned and described be sold by E. INMAN, Master in and for the County aforesaid, to the highest bidder, and the proceeds therefrom to be paid to the party entitled thereto in said Court will appear, and the Master, after having duly advertised the

premises, do hereby on the **1st** day of **July** in the year of our Lord
nineteen hundred and **thirty five** did then openly and publicly, according to the custom of auctions, sell and
convey unto **Nona H. Squires,**

for the sum of **Two thousand (\$2000.00)** Dollars.

NOW, THEREFORE, Know All Men by these Presents That I, E. INMAN, Master in and for the County of Greenville, aforesaid, in consideration of the sum of
Two thousand (\$2000.00) Dollars
by me paid to the said **Nona H. Squires,**

the receipt of which is hereby acknowledged, HAVE GRANTED, bargained, sold, released, and by these Presents DO GRANT, bargain, sell and release unto the said
Nona H. Squires,

"All that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, on the north side of Masley Bridge Road, known as the lower Masley Bridge Road four miles from Greenville Courthouse, being Lot No. 4 in a subdivision of tract of W. S. Rush, containing 5.44 acres, more or less, according to plat by R. E. Dalton, Engineer, August, 1922, having the following metes and bounds: Beginning at corner of Tract No. 3 on north side of Masley Bridge Road, and running thence with line of Lot No. 3, N. 9-30 W. 1060 feet to corner of line of Lot 5; thence with line of lot 5, S. 60-1 E. 176.4 feet to Odd Fellows Orphanage line; thence with Orphanage line and Briscoe line S. 1-15 W. 300 feet; ^{385 feet;} thence N. 62-10 E. 162.5 feet; thence S. 41-20 W. 157.5 feet; thence S. 54.50 W. 237 feet to north side of Masley Bridge Road; thence with the road S. 59-50 W. 368 feet; thence S. 70-25 W. 100 feet; thence S. 79-45 W. 145 feet to the beginning."
