the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said Mattie Hudgens, All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, and being known and designated as lot No. 6 on Plat of Monaghan Annex recorded in the R. M. C. Office for Greenville County in Plat Book "C" at page 63, and having the following metes and bounds, to-wit: Beginning at a stake on the southeast corner of Smythe Street and Parker Road and running thence with said Parker Road, S. 45° E. 115.3 feet to a stake, corner of lot No. 5; thence with line of lot 5 in a northwesterly direction 110 feet to a stake on the East side of Smythe Street; thence with Smythe Street; thence with Smythe Street N. 10-45 E. 29.3 feet to the beginning corner.

Also all that other lot of land in the subdivision known as Monaghan Annex in Greenville County, State of South Carolina, and having the following metes and bounds; beginning on Smythe Street, corner of lot 6, and running thence 110 feet to a stake, thence 16.4 feet to a stake; thence along line of lot 5, 105 feet to Smythe Street; thence with Smythe Street N. 10-45 E. 29.3 feet to the beginning corner.
