All those two certain pieces, parcels or lots of land situate, lying and being in Bates Township, Greenville County, S.C. on the west side of the Beer Highway known and designated as lots #4 and #5 of the *W. H. League* property according to a survey and plat made by *W. A. Hester* on August 18, 1934 and having the following meter and bounds, to wit:
