the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these Presents DO GRANT, bargain, sell and release unto
the said *Joseph Koury*

*All that certain tract of land situated in Ward
Three in the City of Greenville, County of Greenville,
South Carolina, on the West side of Bailey Street
and having the following meter and bounds to wit:
Beginning at corner of Bailey Street known and
designated as estate of Mose Mose, and running
West along said Mose line 75 feet, 8 inches to
corner of Goine property; thence South along Goine's
line 40 feet, 6 inches to corner of Mae E. Washington's
line; thence East along Mae E. Washington's line to
