Anne E. Greene, et al

on or about the *28th* day of *May* in the year of our Lord nineteen hundred and *thirtysix* exhibited *their* complaint in the Court of Common Pleas for the County aforesaid, against *Maudie G. Keating, et al*

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the *7th* day of *August*, 19*36* and such proceedings were had therein as resulted in a Decree

NOW, THEREFORE, Know All Men by These Presents, That I, E. INMAN, Master in and for the County of Greenville aforesaid, in consideration of the sum of *Three Hundred Thirtysix (\$336.00)* Dollars to me paid by the said *Mrs. Carlise M. Teasley*

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these Presents DO GRANT, bargain, sell and release unto the said *Mrs. Carlise M. Teasley*

"All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the West side of Hilton Street, in the City of Greer, being known and designated as Lot No. 4, as shown on plat of property of Mrs. Mary E. Greene Estate prepared by W. A. Christopher, May 6, 1925, and having, according to said plat, the following metes and bounds, to-wit:
