All that certain piece, parcel or lot of land situate in Cleveland Township, Greenville County, South Carolina, situate, lying and being at the southeast corner of the intersection of Ecco Drive and Caesar's Head Drive as shown on plat of property of The Paris Mountain-Caesar's Head Company made October 9, 1934, by R. E. Dalton, Eng., showing Section A of said development, and having the following metes and bounds, to-wit:-

Beginning at an iron pin on the east side of Ecco Drive at the corner of Lot No. 62, which is now owned by the grantee herein, and running thence with the line of said lot N. 67-55 E. 150 feet to an iron pin; thence N. 19-45 W. 126 feet, more or less, to an iron pin on the south side of Caesar's Head Drive; thence with said Drive, in a westerly direction 165 feet, more or less, to a point at the southeast corner of the intersection of Caesar's Head and Ecco Drives and running in a southeasterly direction with said Drive 225 feet, more or less, to the beginning corner.
