KNOW ALL MEN BY THESE PRESENTS, That Highland Water Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina and in consideration of the sum of Seven Hundred (\$700.00) DOLLARS,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Parker Water and

Sewer Sub-district, a body corporate, its successors and assigns,  
A six-inch water main connecting with City Water Line at Judson Crossing, thence along the Easley Bridge Road, in a westerly direction to the present limits of the Parker Water and Sewer Sub-district, at P. and N. Railway right of way, crossing said Easley Bridge Road, and all lateral lines connecting with said six-inch water main within the said Parker Water and Sewer Sub-district, with the right reserved hereby to the grantor to continue said six-inch water main from the limits of Parker Water and Sewer Sub-district beyond the line of said District, as the grantor or its successors may determine, with lateral lines from said main, after it leaves the said Parker Water and Sewer Sub-district.  
Said water line is located in Greenville County, South Carolina, as above set forth.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and

its heirs and assigns forever. subject to the right to use said water main as stated in the granting clause herein.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinafter named, and its

heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, H. K. Townes, President, and Julia D. Charles, Secretary on this the 3d day of June, in the year of our Lord one thousand nine hundred and thirty-six, and in the one hundred and sixtieth year of the Sovereignty and Independence of the United States of America.
