All that certain lot of land situate about four miles north of the city of Greenville on Piney Mountain, known and designated as Lot No. 6 of Blairmont Ridge property, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "N" at page 182, and according to said plat the following metes and bounds courses and distances, to wit:

Beginning at an iron pin on the south side of Piney Mountain Road, joint corner of lots 5 and 6, and running thence with the joint line of said lots S. 49-47 1/2 N. 435 feet to an iron pin on the north side of Blairmont Drive; thence with Blairmont Drive, 100 feet to a point; thence still with Blairmont Drive, 122.18 feet to a point at the corner of lot 6 and 6-a; thence with the joint line of the last mentioned lots N. 48-10 E. 586.5 feet to an iron pin on the south side of Piney Mountain Road; thence with the south side of said Road, S. 34-03 E. 188 feet to the point of beginning.
