All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, just outside the corporate limits of the City of Greenville, S.C., on the West side of M^{rs} Daniel Avenue, being known and designated as lot no. 8 on plat of the J. J. Donaldson property, recorded in Plat Book "B", page 157, P.M.C. office for Greenville County, and more particularly described as follows:
