(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents DO GRANT, bargain, sell and release unto the said R. I. Richardson Lot No. (86) ~~SPRINGWOOD~~ CEMETERY having the following dimensions, to-wit:

Beginning at iron pin corner of lots No's 88 and 90 and running with lot No. 89, 20 ft. to pin, thence S. 65-30 W. 10 ft. to pin, thence N. 24-30 W. to point on line of lot No. 71 thence along said line to corner of lots nos 71 + 72; thence to the beginning

for the right of burial and cemetery purposes, and to be used exclusively for the rights and purposes aforesaid, and subject to the conditions of the Charter of said grantor, and all revisions thereof and amendments that may be made thereto, and also subject to the Ordinances of said ^{town} ~~City~~, and the rules, regulations and by-laws of the ^{town} ~~City~~ Council and Cemetery Trustees or Committee, now in force, or which may hereafter be passed, relating to said cemetery and the burial of the dead therein.

And it does hereby bind itself and its successors in office to warrant and forever defend all and singular the said Premises unto the said R. I. Richardson

heirs and assigns, against itself and its successors in office and against every other person whomsoever lawfully claiming or to claim the same or any part thereof.
