to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto:

W. H. Johnson, his heirs and assigns forever:

All that certain piece, parcel, or lot of land in Greenville Township Greenville County, State of South Carolina containing four and one-half acres, more or less, according to a plat of property of Marsmen, Inc., made by S. A. Ellis, Surveyor, April 3, 1937, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on line of Earle property, joint corner of Lot No. 88 property of N. W. Estes (Ellis plat above referred to) and running thence with Earle line S. 65-33 E. 518 feet to an iron pin, joint corner of lands now or formerly of S. J. Seyle or A. S. New; thence S 60 W. 671.4 feet to iron pin, corner of property of Marsmen, Inc.; thence with Marsmen line N. 14-30 W. 445 feet to iron pin in line of Lot No. 87 of property of N. W.
