

Beginning at an iron pipe on the south side of Courton St. 212 feet east of the intersection east of Courton St. and the Augusta Road and running thence along the back side of Lots 1, 2 and 3, S. 55-30 E. 241 feet to iron pipe on line of lands of R. A. Adams, thence N. 53-52 E. 71 feet to iron pipe, thence N. 49-20 E. 226 feet to Courton St; thence with Courton St, S. 58-19 E. 100 feet to the point of beginning and being known and designated as Lot No. 4 on Plat of property of Thos.
