the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these Presents DO GRANT, bargain, sell and release unto the
said Eva H. Anderson and Eunice J. Andrea

"All that certain piece, parcel or lot of land situate
lying and being in the State of South Carolina and County
of Greenville, on Cannon Street in Greer, having the
following meter and bounds, to-wit: Beginning on an
iron pin on Cannon Street, near M. O. Glenn's corner,
and running thence S. 7-15 W. 191.9 feet to an iron
