All that piece, parcel or tract of land containing one (1) acre in Butler Township, State and County aforesaid, on the Lowndes Hill Road and Woods Lake Road, having the following metes and bounds to-wit: Beginning at a point in the center of the Woods Lake Road 510' 4" East of the intersection of the Lowndes Hill Road and Woods Lake Road running thence North 57.55 West 440' to a point in the center of the Lowndes Hill Road, thence South in the center of said Lowndes Hill Road South 27-45 West 160' to a point in said Road, thence South 65.55 East 132.5' to a point in center of Woods Lake Road, thence South 72-35 East 127.5' to a point in said road, thence S. 81-10 East 160.8' in said road to a point, thence South 82-55 East 90' to a point in said road being the beginning point, said tract of land being in triangular shape.

It is mutually understood and agreed that the Woods Lake Road joint line of said properties of the Greenville Airport Commission and Katie Singleton is to be moved northward at the expense of the grantee so that the line between the respective properties shall still be the center of the said road and both parties agree for location of said road to be changed at this point, the old road being closed and for so much of their land to be used as is necessary to effect this change in equal proportions.

It is further understood and agreed that the grantee is to move wooden filling station which is located on the property being granted to the back yard of the grantee at the expense of the said grantee, said wooden building to be moved and retained in its present condition.
