All of those two certain parcels or lots of land in O'Neal Township of Greenville County, South Carolina, lying on the West side of the Greer-Landrum surface treated road, being all of those lots known and designated as No. 6 and 7 on a plat of the Ervin Forrester property, prepared by H. S. Brockman, Surveyor, dated May 24, 1939, to wit:
