All that piece, parcel or lot of land situate on the east side of Rhett Street, Ward Five (5) in the City of Greenville, County and State aforesaid, being the same lot conveyed to Davis C. Durham by Davis Furman, by deed dated January 18, 1910, and having the following metes and bounds, to-wit:

Beginning at a stake in east line of Rhett Street, eighty (80) feet from N. E. corner of Rhett Street and Hammond Street, thence with line of Rhett Street, N. 38.55 E. 155 feet to stake on a thirty foot street; thence with said street, S. 30.30 E. 62 feet to stake (corner lot formerly owned by Wickliffe); thence with line of last mentioned lot S. 38.55 W. 147 feet, three inches to corner lot owned by Sam'l A.
