the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said C. M. Gaffney

All that piece, parcel or lot of land, with the buildings and improvements thereon erected, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, within the corporate limits of the said City of Greenville, on the West side of McGee Street, and having according to a plat thereof made by Dalton and Neves, Engineers, July 1926, the following metes and bounds, to wit:

BEGINNING at a point on the West side of McGee Street, which point is 102 feet South of the intersection of Henrietta Street (formerly Turpin Avenue) and McGee Street, and running thence along the West side of McGee Street, S. 26-45 E. 51 feet to a point; thence S. 80 W. 155 feet to a point; thence N. 26-45 W. 51 feet to a point; thence N. 80 E. 155 feet to the beginning corner.

As a part of the consideration for this conveyance the grantee assumes and agrees to pay or cause to be paid when due a mortgage in the sum of \$3800.00 which is of record in Vol. 64, page 218 of the R. M. C. Office for Greenville County, S. C.
