Bates of said County and State for and in consideration of the terms, conditions and privileges hereinafter expressed, and the sum of One Hundred (\$100.00) Dollars to me in hand paid by The Greater Greenville Sewer District Commission of Greenville, S. C., the receipt whereof is hereby acknowledged, do hereby grant unto the said Greater Greenville Sewer District Commission, its successors and assigns, the right of way of easement in or upon that lot of land situate in the City of Greenville, County and State aforesaid, bounded by lands of:

Beginning at a point at the southwestern corner and running approximately 82 feet through said property and ending about the center of lot on Townes Street, in the City of Green-ville, which is recorded in the County Block Book 12-1-1-A and City Block Book page #12 as outlined and which faces Townes Street.
