(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said  
W. B. Smith, his heirs and assigns:

"All that certain tract of land, situate, lying and being about four miles from Greenville County Courthouse, on the Hammett Bridge Road, Butler Township, in the County of Greenville and State of South Carolina, adjoining lands now or formerly of P. H. Harbin, Earle Hudson and others; Beginning at a stake on Hammett Bridge Road and running thence S. 18 E. 15.24 to a stone; thence S. 68 W. 15.00 to a stone; thence N. 6 W. 17.50 to side of old road; thence N. 68 1/2 E. 4.63 to center of bridge; thence N. 82 E. 6.86 to the point of beginning, containing 21 3/4 acres, more or less.

ALSO:

"All that certain lot of land situate, lying and being in the County of Greenville and State of South Carolina, containing 20 acres, more or less, about four and a quarter miles from Greenville County Courthouse, in Butler Township, on the south side of the old Spartanburg Road; Beginning on a poplar on said road, running thence S. 18.00 E. 23.50 chs. to a stone; thence N. 36.75 E. 14.00 chs. to a stone on Spartanburg Road; thence along said road N. 73 1/3 W. 4.10 chs. to a stake; thence N. 63.50 W. 10.50 chs. to a stone; thence N. 87.25 W. 2.50 chs. to a stone; thence S. 82.50 W. 3.50 chs. to the point of beginning.
