All that certain piece, parcel or tract of land, situate, lying and being in O'Neal Township, Greenville County, State of South Carolina, containing thirty-nine and four tenths (39.4) acres, according to plat thereof by H. S. Brockman, Surveyor, dated August 14, 1937 and having the following courses and distances, to-wit:

Beginning at a large stone, eastern corner of said tract, and running thence N. 23.45 E. 412 feet to an iron pin; thence S. 85.40 W. 543.4 feet to an iron pin on second break of waterway; thence S. 56.30 W. 585.5 feet to an iron pin at mouth of waterway; thence S. 86.30 W. 1656 feet to middle of South Tiger River, 1637 feet to an iron pin on bank of river; thence down said river as a line S. 42.15 E. 98.5 feet to bend; thence S. 58.45 E. 100 feet to bend; thence S. 64.00 E. 100 feet to bend; thence S. 41 E. 350 feet to bend; thence S. 1.00 W. 100 feet to bend; thence S. 30.30 E. 100 feet to bend; thence S. 6.00 E. 100 feet to bend; thence S. 12.00 E. 100 feet to iron pin on bank of river; thence N. 83.00 E. 738 feet to stone near holly, 756.5 feet from middle of river to stone near holly; thence N. 62.00 E. 1749 feet to beginning corner.
