TITLE TO REALESTATE

Line C - An 8" line beginning at a manhole, Station 13+31 on line B above described, and running thence in a southeasterly direction 576 feet to a manhole in the center of Haviland Avenue; thence in a southerly direction in Naviland Avenue 384 feet to a manhole in the intersection of Beachwood Avenue and Haviland Avenue.

Line D - A 12" line beginning at a manhole in the 18" trunk sewer, said manhole being approximately in the projection of Whitsett Street to its intersection with the said trunk sewer, and running thence in an easterly direction 121.3 feet to a manhole just west of Richland Way; thence in a northeasterly direction, paralleling Whitsett Street and a stream 915.3 feet to amanhole, Station 10+59.3; thence in an easterly direction continuing parallel with said stream 912.2 feet to a manhole at or near the City line.

Line E - An 8" line beginning at a manhole in the 18" trunk sewer, said manhole being at or near the intersection of Spartanburg Street with said trunk sewer, and running thence in a north-easterly direction to the east of and in the said Spartanburg Street a distance of 313.3 feet to a manhole at the intersection of Mount Zion Street with Spartanburg Street.

Line F - An 8" line beginning at the manhole above mentioned as the beginning point of Line E above, and running thence in a northeasterly direction 343.8 feet to a manhole near the City line approximately 200 feet easterly from Spartanburg Street.

All of the above described sewer lines being those covered by an agreement between the City of Greenville and Greater Greenville Sewer District dated April 21, 1931.

All of the above lines except line A from the trunk sewer to McDaniel Avenue are shown on maps attached hereto.

Third: All of the right, privileges and easements in, over and to such of the streets, parks, alleys or other public property owned by the said City or dedicated to the public use in the City of Greenville as contain any of the sewer lines hereinabove described.

Together with the right to construct, maintain in and upon and use in and through said premises in a proper manner, with necessary apparatus and appliances, such as machinery, air vents, manholes blowoff connections and any and every other necessary and proper attachment, pipe lines for sewerage purposes through the premises above described, together with the right at all times to enter in and upon said premises for the purpose of inspecting and making necessary repairs and alterations thereon of said line, together with the right to cut away and keep clear of said pipe lines all trees and other obstructions that may in any way endanger the proper operations of same.

This deed is made pursuant to the authority contained in the Resolution duly adopted by the City Council of the City of Greenville in meeting assembled on the 9th day of November, 1937 certified copy of which will be found on file in the office of the City Clerk and Treasurer.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in any wise incident or appertaining.

To Have and to hold all and singular the premises before mentioned unto the Grantee here-inabove named and its successors and assigns forever.
