All that certain lot or parcel of land in Greenville Township, Greenville County, State of South Carolina, about two and one-half (2½) miles south of the City of Greenville on the East side of the Augusta Road, and being known and designated as Lot #13 as shown on a plat of the Smith property as made by C. M. Furman, Surveyor, and recorded in the office of the RMC for Greenville County, S. C. in Plat Book F, page 108. By reference to that plat it will be found that the said lot #13 faces on Tallulah Drive with a frontage of 100 feet and runs back to a depth of 200 feet.
