

The easement granted herein to be for the construction of a power line running parallel with the Airport Road hereinafter referred to, said easement herein granted lying on the south side of said Airport Road.

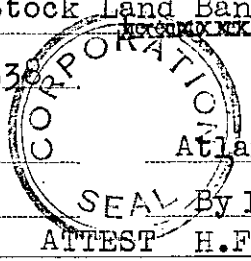
