

EXCHANGE PLANT PERMIT.

Received of the Southern Bell Telephone and Telegraph Company, One Dollar in consideration of which I hereby grant unto said Company, its associated and allied companies, their respective successors and assigns, the right, privilege and authority to construct, operate and maintain its lines of telephone and telegraph, and for the general transmission of intelligence, including the necessary underground and aerial cable, conduit, poles, wires and fixtures with the further right to permit the attachment of the wires of any other company, or person, to said poles and fixtures upon and over or under the property which I own near the City of Greenville, County of Greenville and State of South Carolina; said sum is recorded in full payment of said rights.

The above mentioned property being that Sub-division known as "Lanneau Drive Highlands", as per plat made by Dalton and Neves, Engineers, August, 1937.

The following is a description of the location in which the said lines shall be constructed and maintained;

IN BLOCK BOUNDED BY

E. Faris Road, Ponce De Leon Drive, Ottoway Avenue and Lanneau Drive.

Line to be constructed along the West property line of lot number 3 and the East property line of lot number 31 from E. Faris road to rear property line of said lots, thence along the rear property line of lots fronting on E. Faris road, Ottoway avenue, Ponce De Leon drive and Lanneau drive.

IN BLOCK BOUNDED BY

E. Faris road, Lanneau drive and Ottoway avenue.

Line to be constructed along the rear property line of lots fronting on E. Faris road, Ottoway Avenue and Lanneau Drive.

Lots Fronting on Lanneau Drive and E. Faris Road

Line to be constructed along the rear property line of lots fronting on Lanneau drive, E. Lanneau drive, and E. Faris road.

While the line is supposed to run along the property lines of the aforesaid lots, the right is granted for the lines to be constructed on any road, avenue or drives in order to connect the line running from one block to another.

In addition to the rights conveyed above, the Telephone Company is authorized the right to trim and cut trees so as to clear and keep cleared said Company's plant; said sum is also received in full payment of said rights.

The company agrees to re-locate at its own expense, on said property, its lines and fixtures to conform with future building improvements.
