Jerry H. Reeves, his heirs and assigns:

All those certain pieces, parcels or lots of land, with the improvements thereon, situate, lying and being on the northwest side of West Tallulah Drive near the City of Greenville in Greenville Township, Greenville County, South Carolina, known and designated as Lots Nos. 10 and 11 on plat of property of Estate of D. W. Cochrane made by Dalton & Neves, Engineers, July, 1937, and having, according to said plat, which is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book I at pages 92 and 93, the following metes and bounds, to-wit:-

Beginning at an iron pin on the northwest side of West Tallulah Drive, joint corner of Lots Nos. 9 and 10, said pin also being 330 feet in a westerly direction from the northwest corner of the intersection of West Tallulah Drive and Augusta Road, and running thence with the line of Lot No. 9 N. 34-10 W. 230.9 feet to an iron pin; thence S. 46-27 W. 141.87 feet to an iron pin, joint rear corner of Lots Nos. 11 and 12, thence with the line of Lot No. 12 S. 34-10 E. 207.8 feet to an iron pin on the northwest side of West Tallulah Drive; thence with said West Tallulah Drive N. 55-50 E. 140 feet to the beginning corner.
