All that certain piece, parcel or tract of land situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, located about four miles from the City of Greenville and having the following courses, distances, metes and bounds to-wit:

Beginning at a stake on the northeast side of right-of-way of Federal Highway #25, 20.5 ft. from corner of F. H. Hill's land where county road intersects said highway; thence along the north boundary of said county road N. 72-30 E. 70 ft. to stake; thence continuing along the north boundary of said county road S. 87-45 E. 671 ft. to stake 20.5 ft. from iron pin in line of Hill property; thence N. 16-30 W. 490 ft. to stake; thence S. 63-0 W. 780 ft. to iron pin on right-of-way of Federal Highway #25; thence along said Federal Highway right-of-way in a southerly direction 150 ft. to stake at point of beginning, and containing 5 acres, according to survey made by Dalton and Neves, Engineers, July 1938.

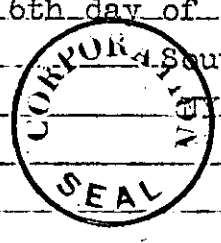
