All that piece, parcel or lot of land, situate, lying and being in the State and County aforesaid, about two and one half miles from the Court House near the Easley Bridge Road, being known and designated as a portion of lot number 9 of the property of W. 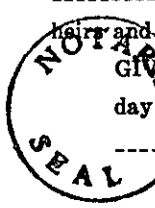
