Scott, and by these presents do grant, bargain, sell and release, after life estates of myself and my husband, W. A. Scott, unto the said B. A. Scott,

All that tract or parcel of land containing two hundred fifty-nine and one-half (2592) acres, in Dunklin Township of Greenville County, South Carolina, known as the Scott place, located on the Horse Creek Road, ten (10) miles from Honea Path, on the head waters of Horse Creek, bounded on the north by lands of J. E. Knight (deceased); on the east by lands of Melvin Thomason and Cothran; on the south by lands of J. A. McCullough (deceased); on the west by lands of Horton, and having the courses and distances according to survey and Plat of W. M. Nash, Surveyor, October 24, 1912, which plat is now in possession of the Federal Land Bank of Columbia, Columbia, South Carolina.
